Botvin's LifeSkills Training was implemented with 7/8th grade students during a summer camp program. Project ALERT is implemented with all 7/8th grade students. Project SUCCESS is used with continuation high school students at the three alternative education schools.

Project TND is used by Panacea Counseling Inc. in the intervention/cessation support provided at 9 secondary schools. 386 counseling support groups were completed, but not all are TND specific.

Comments regarding question 4:

TND groups were facilitated at 9 secondary schools (7th-12th grades). Data is not available to determine specific grade level for individual students in these groups.

Comments regarding question 6:

Programs such as Link Crew, Club Live and Triple T impact far more students than indicated. These program utilize peer outreach, advocacy and education and can, with certain activities, impact an entire campus. The numbers listed above reflect the regular membership of these programs, not the additional students who may be exposed and impacted by the activities.

8 secondary schools participated in RRW, 2 schools indicated participating in Kick Butts Day and one school participated in the Great American Smokeout. The EGUSD has attempted for the past three years to implement Intervention with Teen Tobacco Users (TEG). This program has not met with success despite efforts from TUPE staff to promote and offer incentives for student participation. Students were provided bus passes, snacks and other incentives for participation. The program was also used in leiu of suspension. Despite this it was extremely difficult to maintain more than 2-3 participants at a time. EGUSD will be switching to "Teen Intervene".
