REACH One Alliance with Kevin Bracy was piloted at Encina High School and projected to reach 827 students. A school-wide assembly was held reaching over 800 students followed by a 2-Day workshop facilitated by Kevin Bracy with 157 students 2 certificated staff and 1 classified staff participating. Weekly REACH One Alliance huddles were facilitated by the REACH One Alliance Teacher/Advisor reaching 30-40 students each week. The focus of the weekly huddle was youth advocacy. Each student was responsible for reaching out to at least one student each day with the

Kevin Bracy of REACH One Alliance was selected to provided tobacco use prevention educaton at two Family Night Out events reaching 302 students and parents. Mr. Bracy also provided a school-wide assembly at Encina high school, and facilitated a 2-Day workshop at Encina High School for 9-12 grade students. Dr. Victor DeNoble was selected to present tobacco use prevention educaton during the Don't Buy The Lie contest held in March 2014. Dr. DeNoble was the keynote speaker for the March 2014 Family Night Out reaching 66 students and parents.

REACH One Alliance piloted at Encina High School is a Youth Development strategy focused on creating the next generation of tobacco-free students. The weekly huddles tasked students with reaching one student each day to promote a healthy tobacco free life style. The daily themes are: Make a Difference Monday, Text2Empower Tuesdays, Win the Day Wednesdays, Live the Change Thursday and Healthy and Happy Friday. Over 800 attended the school-wide assembly, 157 students particiapted in the 2-Day workshop and 30-40 attended weekly huddles.

Minnesota Smoking Prevention Program (MSPP) was available to all middle, K-8 and high school students. Sessions were administered in the classroom by the teacher. Additionally, Prevention Specialist presented MSPP sessions at two of the district's high schools. MSPP for parents was offered and facilitated by the TUPE Program Coordinator at three school sites reaching 38 parents and 22 of the district's Parent Liaisons.
